## **PERSONAL DATA PROTECTION AGREEMENT**

Darimex Techno SRL is a Romanian legal entity, having as its main object of activity the trading of tools and equipments for the food industry, the trading of food additives and artificial membranes, as well as installation, mounting and service activities.

Darimex Techno SRL has its registered office located in Otopeni, no. 17 I.I.C Bratianu Street, Ilfov County, zip code 075100, telephone no.: 021 2360755, fax no.: 021 2360759, and it is registered with the Office for Trade Register under the no.: J23 / 348 / 2014, having the tax code: RO 6769187 and the IBAN account: RO 32 RZBR 0000 0600 1272 2919 opened with Raiffeisen Bank Otopeni and it is duly represented by Mr. Mihai Sorin Korodi – General Manager.

Darimex Techno SRL processes personal data, under adequate technical and organizational security conditions, and such processing is duly conducted upon compliance with the legislation in force.

DARIMEX TECHNO SRL processes the personal data received directly from the data subjects, upon running any relevant trade / contractual relations and / or upon attending any fairs / exhibitions / events, as duly organized.

Personal data are collected either only with your own agreement to this end, or if the same are willingly supplied on one's own initiative, or upon the request of the company DARIMEX TECHNO S.R.L., for instance by any contractual documents, invoices, offers, by one of the on-line forms in use, namely the online contact form, by filling in the details in the registration form on DARIMEX TECHNO SRL website, etc.

In view of accomplishing its object of activity and for the good running of the current business activity and for the enforcement of the legal provisions on the protection of natural persons in terms of the processing of the latter's personal data and the free traffic of such data (domestic law and community law), DARIMEX TECHNO SRL shall be under the obligation safely manage the personal data it has been provided with, and only for the defined purpose.

DARIMEX TECHNO SRL shall not process such personal data but to the extent any such action shall be required and necessary for the due accomplishment of the above described purposes, upon compliance with the legal measures on data confidentiality and security.

Personal data processing stands for any operation or series of such operations, which shall be conducted in terms of your own personal data, by any automatic or non – automatic means, such as: the collection, recording, organization, structuring, storage, adjustment or amendment, extraction, checking, using, disclosure by communication, dissemination, or making available in any other way whatsoever, the alignment of or combination, restricting, erasure, destroy or archiving any such data.

Given the running of the present business activity of DARIMEX TECHNO SRL, including the conducting of the trade / contractual business and / or the company's attendance at any exhibitions, fairs and / or other such specialized events, as well as given the accomplishment of the due legal obligations in force, our company may ask you to supply certain personal data, such as: name and forename, signature, telephone / fax, email, position, etc.

Those data subjects whose data may be processed by Darimex Techno, exclusively for the purposes below described, are, depending upon case:

- The entity DARIMEX TECHNO SRL legal entity clients, or the latter's representatives / empowered individuals, duly authorized at either a legal or conventional level, the business contacts / business partners / contractual partners.

By reading the present provisions, and / or by signing any document by which one supplies such personal data to DARIMEX TECHNO SRL, or by supplying any personal data for the purpose of accessing the services provided by DARIMEX TECHNO SRL, the data subjects shall be duly informed and / or the latter shall state their express consent (and agreement) on the processing of their personal data in compliance with the legal dispositions on the protection of natural persons in terms of the processing of the latter's personal data and the free traffic of any such data (domestic law and community law).

If data processing is no longer necessary for the purpose of providing a certain service, or in view of accomplishing any legal obligation, nor is it justified by any legitimate interest of DARIMEX TECHNO SRL, the data subjects may decline any such processing or the latter may withdraw their consent and approval, as previously given, and their denial shall bear legal effects in terms of the future.

The purpose of collecting such personal data is:

- To run the trade / contractual business activity of DARIMEX TECHNO SRL;
- To invoice and cash the value of the services provided by DARIMEX TECHNO SRL;
- For marketing, promotion, including the sending of general or customized trade offers; for the due services development and improvement;
- Customer relations management; commercial communication with the clients / suppliers by any communication means;
- Accomplishing the incidental legal obligations;
- Communicating with the public or public interest bodies / authorities / institutions;
- Audit and control / supervision related activities;
- Archiving, statistic purposes;
- Collecting debts / recovering outstanding debts;
- Settlement of any disputes and litigations, the enforcement of any court judgments, arbitration decisions, court orders, etc.

Darimex Techno SRL shall consider any and all information received from you as being confidential and shall not share the same with any third parties whatsoever, without your express prior consent to this end. These data recipients may be the every data subjects having supplied their personal data, as follows:

- The legal entity clients of DARIMEX TECHNO SRL (current, former or potential), the latter's representatives / duly empowered individuals, at either a legal or at a conventional level (for the purpose of running the relevant trade / contractual relations)

The recipients of such data (other than the data subjects) may be:

- Central and local public authorities, court authorities, police departments, prosecutor's offices (within the limits of the legal provisions in force and / or as a result of some petitions having been duly filed), bank companies, legal executors, insurance and reinsurance companies, market research companies (for statistical purposes), etc.

Within their du relation with the company DARIMEX TECHNO SRL, the data subjects shall benefit of the following rights, as per the applicable legal provisions, namely: the right of access, the right to rectify, the right to erase one's data, the right to restrict the processing, the right to data portability, the right to oppose.

The length of processing such personal data

In view of accomplishing the above described purposes, DARIMEX TECHNO SRL shall process the personal data across the entire length of running the activity until the time when

the data subject, or the latter's legal representative shall exercise his right to oppose / erase (save for the case when DARIMEX TECHNO SRL shall process the said data based upon any legal obligation or if this justifies any legitimate interest). Following the end of the activity relating to processing of such personal data, for the purpose for which the same has been collected, if the data subject or the latter's legal representative shall fail to exercise the right to oppose / erase such data according to the law, any such data shall be duly archived by DARIMEX TECHNO SRL across the length of time stipulated within the internal procedures of DARIMEX TECHNO SRL and / or the same shall be destroyed.

In order to avoid the unauthorized use of the personal data, as well as any eventual deeds of abuse, our company uses security technology and methods, alongside a series of adequate working procedures and policies, so as to protect the personal data we have collected.

Full security of the data sent on the Internet may never be guaranteed. While DARIMEX TECHNO SRL uses its best efforts so as to protect the said personal data, the security of the data sent to the website of DARIMEX TECHNO SRL can never be completely guaranteed. Any data transfer shall be made on the data subjects' risks. Once such personal data are received, DARIMEX TECHNO SRL uses a series of strict security procedures and measures against any unauthorized, illegal use, destroy, accidental loss or disclosure of any such personal data.

Data transfers outside the EU space and the EEA may only be carried out under the conditions stipulated by the domestic and the EU specific legislation on the protection of data subjects as related to the processing of the latter's personal data and the free traffic of any such data.

By reading and signing the present document, the data subjects shall hereby duly acknowledge that they have been notified on the rights they have, as per the applicable legal provisions, namely: the right to access, the right to rectify, the right to erase the data, the right to restrict the processing, the right to data portability, the right to oppose. Also, in those cases when the processing is duly performed based on a due consent to this end, the data subjects shall be entitled to withdraw any such consent at any time whatsoever in writing, which document is to be duly sent to the DARIMEX TECHNO SRL, under the due legislation in force, without any prejudice whatsoever as to the legality of the processing having been conducted based upon such consent prior to one's withdrawing the same.

For any other purposes, the data subjects shall be entitled to oppose, at any time whatsoever, on a free of charge basis, to their personal data being processed, as such data they have supplied to DARIMEX TECHNO SRL, so as for the same to make up the subject matter of any such processing, with the listing of the data and purposes taken into account, only on solid and legitimate grounds, as related to their particular status, save for the cases when DARIMEX TECHNO SRL shall bring proof to the fact that it has legitimate and imperious grounds that justify such processing and which prevail over the interests, rights and freedoms of the relevant data subject, or that the purpose is represented by the finding, exercising or defending of any right in court. In the event of any unjustified opposition, DARIMEX TECHNO SRL shall be entitled to keep on processing the relevant details.

By reading the present document, the data subjects have become duly aware of and they understand and agree upon the fact that the personal data they have supplied to Darimex Techno stand for determinant elements for the purpose of accessing the services provided by Darimex Techno SRL and / or for the running of the trade / contractual activity.

If the data subjects shall either directly or by representative exercise the rights above described, in an obviously ungrounded manner, unjustified or excessive manner, particularly due to the repetitive character of any such actions, DARIMEX TECHNO SRL may:

- Either charge a reasonable fee upon consideration of the administrative costs implied by the supply of information or the communication or for the taking of the requested measures;

- Or deny proceeding with such request.

Also, if the data subjects, shall either directly or by representative exercise any right to oppose in an obviously ungrounded, unjustified or excessive manner, particularly given the repetitive character of any such actions, DARIMEX TECHNO SRL shall be entitled to deem the Agreement concluded with the Client as terminated by default, without any other formality or with no other intervention from any courts of law, save for a prior notification to this end. In order to exercise these rights, you may address the individual in charge with personal data protection within DARIMEX TECHNO SRL, by means of a written request, which shall be duly dated and signed, by sending the same at the following address: [office@darimex-techno.ro](mailto:office@darimex-techno.ro), or at the following mail address: DARIMEX TECHNO SRL, Otopeni, no. 17 I.I.C. By signing the present contractual agreement, you shall hereby acknowledge having read, having been accurately informed, in a full and precise manner, as well as having become fully aware and duly agreeing upon the following:

- The provisions of the present document;
- The fact that the processing of personal data, as the same is stipulated under the due legislation in force, within the present writ is to be conducted in any and all cases, for the performance of a due agreement, the accomplishment of any legal obligations or for the fulfillment of any legitimate interests of Darimex Techno SRL, as well as by virtue of the consent you have given us in terms of the relevant option and by signing the present document, which consent has been stated in an express, non – equivocal, free and informed manner, in the event of any personal data processing for marketing purposes.
- The fact that DARIMEX TECHNO SRL shall not process your personal data but to the extent such action is duly required for the purposes above described, while at the same time complying with the legal data security and confidentiality measures.
